3. Negative Coggins within 12 months must be presented on each horse before they can play or practice in Aiken as per SC State law.
4. All Players must sign the 302 POLO CLUB RELEASE, INDEMNIFICATION WAIVER AND COVENANT NOT TO SUE AGREEMENT before going on the field to play or practice. Copies will be available from tournament organizer, or downloaded from [www.302polo.com/forms.shtml](http://www.302polo.com/forms.shtml)
5. Tournament fees shall be paid upon entering the tournament. Checks shall be made payable to 302 Polo and sent to 302 Polo LLC, 491 Burkelo Rd, Wagener, SC, 29164. No team will be entered in the draw without the entry fee paid. After the draw, entry fee is non-refundable.
6. Any team with scheduling conflicts must make them known to tournament coordinators upon entering.
7. Each game will be officiated by two USPA umpires and one third man.
